

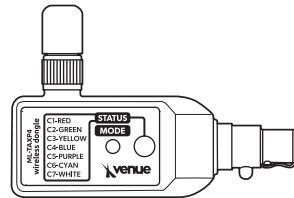

TRANSMITTER AND RECEIVER



The VenueLink Wireless DMX Dongle is compatible with Venue products with a VenueLink port (VP) and Venue products with an integrated VenueLink receiver (VI). This dongle allows for the transmission of 512 channels of wireless DMX commands to compatible devices up to 100' away, eliminating the need for XLR cables. It is also powered by the fixture it is connected to and does not require charging nor batteries. The dongle will automatically detect whether it is connected to a controller or lighting fixture, and will act as a transmitter and receiver accordingly.

INSTRUCTIONS

1. Plug the VenueLink Wireless DMX Dongle into the VenueLink 4-pin jack. Make sure the connection site clicks to lock in place.
2. Set the DMX channel of the light fixture to the desired value.
3. Press the button on the dongle to toggle through universes. To transmit and receive DMX signal between a controller and light fixture, the LED should blink the same color. There are seven available universes that can each contain up to 32 fixtures.
4. Dongles acting as transmitters blink faster than those acting as receivers.
